Industry Guideline Information on Restrictions on the Use of Plant Protection Products on Deciduous fruit for 2025/26 - VERSION 2 - October 2025, on HORTGRO website

For your information amendments to this version include:

SA/EU/GB/Export default MRL and/or export default withholding period information/ Codex MRL information:

- **Acetamiprid** - EU MRL on apricots, peaches & nectarines, plums, cherries, pears, apples and table grapes
- **Deltamethrin** - Export Default Withholding Period on plums
- **Fenbuconazole** - EU MRL on apricots, peaches & nectarines and plums
- **Penconazole** - EU & Export Default MRL and Export Withholding Period on apricots and peaches & nectarines, EU MRL on plums, pears, apples and table grapes
- **EU MRLs**, take note of proposed Draft EU MRLs (not applied regarding Export default MRLs since they are unpublished), which once published will impact on future EU MRLs.
- **Please note:** Given differences between GB/UK MRL's and EU MRL's, in cases where the GB/UK MRL is lower than the EU/SA MRL, the Export Default MRL is based on the strictest.

Inclusion of newly registered/additional actives:

- **Bacillus Thuringiensis** (DiPel DF) on pears

Update on substances of concern:

Regarding the Version 1 – July 2025 Fresh Notes, including information related to the above, confirmation was received relating to Agricultural remedies reclassified for mancozeb-containing products, as follows:

- BASF confirmed "reclassification" and approval of continued use for Acrobat WG (L6526), on Hortgro table grape list.
- Villa Crop Protection confirmed "reclassification" and approval of continued use for Villa Unizeb 750 WDG (L8812), Villa Unizeb 800 WP (L8056), Cymoxazeb WP (L7694), Newzeb 750 WDG (L8811) & Metazeb 700WP (L7463), on relevant Hortgro stone fruit, pome fruit & table grape lists.
- Farm-Ag International confirmed "reclassification" and approval of continued use for Farm-Ag Mancozeb 800 WP (L4754), Cymostar 760 WP (L11332) & Metastar 700 WP (L10846), on relevant Hortgro stone fruit, pome fruit & table grape lists.

Colour-coding for the above confirmed reclassified products has been amended to green in our Version 2 – October 2025 documents, as per the below key included in our Version 1 – July 2025 Fresh Notes.

Please review trade names to confirm further verified/ newly registered trade names provided by agro-chemical companies for this version.

As previously indicated, agrochemical labels constitute the legal entity and must always be consulted to confirm registration of products/trade names on relevant deciduous fruit crops, prior to use. It is strongly recommended that producers request product labels as reference to confirm registration of given trade names on relevant deciduous fruit crops, prior to purchase/use of the product.

Regarding MRL information per country:

Amendments to the previous version are not highlighted, however, as previously indicated, the **MRL Notes** column flags actives which have no MRL (indicated as -) or MRL's lower than the export default MRL, based on specific country MRL's or Codex MRL's, in cases where Codex is/may be applied (ie. MRL values in square brackets, under MRL Notes). **It is recommended that these are reviewed in conjunction with MRL information per country, as required.**

Please review information per fruit type, as required, for further details.
